NHSScotland Property Transactions Handbook update

CEL 8 (2011), issued in February 2011, notified NHS Boards of the publication of a revised edition of the NHSScotland Property Transactions Handbook.

Colleagues may be aware of recent Scottish Government legislative and policy changes which have resulted in amendments to the Scottish Public Finance Manual (SPFM).
